TRAINING ISSUES

Documenting CCU and ITU experience It is essential that trainees document their CCU and ITU experience. This is best done by keeping a summary log of the cases seen on CCU and ITU and linking it with reflection or assessment. This should then be signed off by your Educational Supervisor to be of any use at the G(I)M PYAs.

MRCP Diabetes & Endocrinology This exam has to be completed and passed by all trainees appointed after August 2007 before their PYA. We recommend sitting it ASAP and well before your PYA.

The Kelly-Young MRCP Diabetes & Endocrinology Prize This prize is awarded annually at NERRAG to the youngest in terms of training year StR passing the MRCP Diabetes & endocrinology exam. Richard Quinton secures the funding of £400 and it is named after 2 distinguished former Endocrinologists in the region, Bill Kelly and Eric Young.

Critical incident/complaint If you are involved in a critical incident or if reporting an incident concerning training issues please inform your supervisor and the TPD. Ensure they are reflected upon in your portfolio

Portfolio Completion It is essential for trainees to engage with their portfolio on a regular basis and record learning. It is also essential to record the numbers of patients seen as news or reviews for clinics, on-call, ambulatory care. It is essential to record the number of specialty clinics undertaken. Undertaking this activity means that your Educational Supervisor should be able to engage with the portfolio so as to provide you that assessment for ARCP purposes.

GMC Survey 2018: Dear all I am delighted to share the feedback about our speciality from the GMC NTS 2018. The results speak for themselves but it's important I take this opportunity to thank each and every clinician involved in providing high quality speciality training. Trainee's engagement is key and they have consistently taken lead on various aspects to make it a true trainee led trainer supported training programme.

NTS results:

- 1. The training programme was ranked within the top 3 ranks nationally in the GMC Trainee survey 2018 in 15 of the 19 domains.
- The training programme was ranked 1st nationally in the GMC Trainee survey 2018 in 7 of the 19 domains.

- Nationally the lowest score in Induction (2016) has improved to 1st rank. 18 out of 19 domains were in top 5 ranks nationally
- 7. The programme is only one nationally not to have any pink or red outliers.

Thank you to all the STC members and all the consultants at RVI lead by Stuart Little and Simon Pearce who brought about necessary changes that helped the trainees to acquire competencies in various aspects of sub speciality training. We managed to improve the feedback and get rid of previous years red outlier score.

Summary of Local Trainees Survey 2018 (Led by STC trainee reps): The feedback is mainly from units which has more than one trainee. Overall the feedback from speciality point of view has been rated as extremely positive. All of them rated quality of training as good or excellent, overall satisfaction was rated satisfied or very satisfied. Trainees rated opportunity to attend various speciality clinics as excellent. Opportunity to attend regional teaching and take required study leave was rated very positive. None mentioned facing undermining or bullying behaviour. Majority of the negative comments were related to impact of G(I)M on calls on speciality training. Difficulty to obtain G(I)M assessments from G(I)M consultants has been raised as well. I will feedback this to training units via respective STC members.

Recruitment: National second round interviews for speciality registrars happened on September 18th at Bristol. I and Dr Little were on the interview panel. We went out to recruit minimum 9 posts. 43 candidates were interviewed for potential 48 posts.

Recruitment 2019: we are due to interview on March 27th 2019 for Round 1 of academic year 2019-2020. Interviews will be held at St James Park Newcastle. Please let me have your availability to be on the interview panel.

Management session for trainees: I along with my good friend Dr Naineni, GP and Faculty at Brighton Medical School were involved in training of registrars in Human Factors in Healthcare and Listening in Healthcare.

My sessions focussed on key HF based themes such as team working, decision making process, fatigue and situational awareness. They were taught using well established HF models in relations to daily clinical work.

Dr Naineni covered "Listening in twenty-first century health care". There is lot of evidence to affirm that effective listening is fundamental to personal, professional, organisation development and success. Despite this, listening is not covered in depth in the educational

training activities. As we all know listening effectively is becoming extremely difficult due to significant barriers amongst which time constraints and ever increasing workload are the major barriers. It can be argued that the need for effective listening in healthcare is more now than ever. With this premise we integrated listening education and training into registrar management forum. Feedback reflects that it has been well received.

The first part of the training focussed on discussion about the listening concepts, latest listening research and listening models. This session formed launch pad for the second session which focussed on assessment of individual listening competences. For this part I have used ECHO (Effective Communication for Healthy Organisations) Profile. This has a robust validity portfolio. The profile not only helped registrars to be aware of their strengths and challenges about listening but also provided them with tailor-made listening strategies. We discussed ways in which these strategies can be implemented in their busy clinical practice. This is an initial step towards making the healthcare professionals better listeners.

The sessions were interactive and we used practical examples provided by the registrars during discussions. The discussions were lively and relevant.

Senior registrars, appreciating the value of these sessions, requested us to provide the same to the new cohort of registrars next year.
